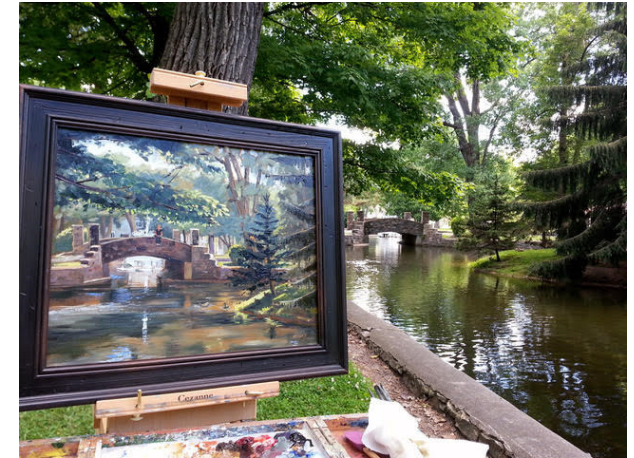

## EXHIBIT STATEMENT:

This main gallery will feature works of Plein Air Artist Thomas Buchs.

Plein Air artists who complete works between Sunday, August 23rd and Saturday, August 29, 2020 will be invited to show their works in our “wet room”.

Artists may choose to sell their items or make them not for sale (NFS). Artists are encouraged to sell their work to support the DCCA, themselves and make art readily available to the public.

We will invite the public to vote for their favorite piece. Each participating artist will also vote for their favorite. Certificates will be awarded at the opening reception.

Please research an area that you would like to paint and sign up via our website so that we can provide a map to interested parties.

## ELIGIBILITY:

- Artists must be a current member of the Dodge County Center for the Arts
- Art works must be original —no kits
- Wall hung art must be framed and wired for hanging
- No diptychs or triptychs
- Framed artwork, including frame, not to exceed 3' x 3'
- Wall hung art not to exceed 30 pounds
- Artists must complete work between August 23rd and 29th

## MEDIA:

Open to all Plein Air Art media created between Sunday, August 23rd and Saturday, August 29, 2020

## SALES:

The DCCA will sell your art during the Plein Air Festival. Art will be marked as sold and will be available for pickup *Sunday, September 27, 3-5 pm*  
*Monday, September 28, 10 am – noon*

## COMMISSIONS:

- DCCA will sell art works only at retail price on Artist's Submission Form
- DCCA and artist agree that 35% of the retail price will be due to the DCCA

## INSURANCE:

Artists must provide their own insurance on their work.

## SALES TAX:

DCCA assumes the responsibility to collect and pay the appropriate WI state and Dodge County sales tax on all works sold. Sales tax will be added to the retail price of the work as established by the Artist.

*The exhibit committee has the discretion to refuse any artwork that does not meet any criteria.*
